Terms and Conditions of Donating Money Using the Website of SIGMA Foundation

Donation to SIGMA Foundation

Anyone who donates money to SIGMA Foundation using its website, which is owned and maintained by SIGMA Foundation, is to abide by the terms and conditions mentioned below, which is amenable to change from time to time. One should not donate any fund to SIGMA Foundation, if he/she is not agreeable to abide by the terms and conditions.

General Terms and Conditions

Donations to SIGMA Foundation are exempt from income-tax under Section 80G (5) (vi) of the Indian Income Tax Act, 1961. For online donation by any donor, certain information such as donor's name, address, phone number, email address, PAN number, if available, and purpose of donation will be required to be submitted for record. As per Indian Income Tax rules, a donor with Indian passport is required to add their Address and PAN number in case they wish to receive the 80G tax-exemption certificate. Every donation will be thankfully acknowledged with a receipt containing the details of the approval given to SIGMA Foundation based on which exemption can be claimed by the donor and the receipt will be shared with the donor online or by post, if mail address or phone number having internet access is not available.

Disputes and Refunds

The donors can make a complaint online at info@sigma.foundation and the same will be investigated at the earliest opportunity and with utmost care. The findings/ resolution of the dispute will be communicated to the complainant as soon as possible. No refunds will be entertained after the instant tax exemption has been issued. In case, the donor finds that some mistake has taken place in providing information, the same may be communicated through a signed letter which can be forwarded in the mail address info@sigma.foundation or the letter may be delivered physically/ through courier in the office address at AI-171, 1st Floor, Street No. 29, Action Area I, New Town, Kolkata-700156, West Bengal, India.
